We are pleased to share the Auxiliary Data Collection Tool can now be utilized for the Shockwave dataset and is available for all CathPCI Registry participants! Navigate to the Documents Home Page and locate the CathPCI Aux Data Collection Tool Companion Guide to learn all about it.

Patients in the CathPCI Registry, who received PCI and in whom a Shockwave Intravascular Lithotripsy (IVL) System with Shockwave C2 Coronary IVL Catheter was utilized, should be abstracted in your CathPCI Registry v5 data collection tool addressing all relevant questions as usual. Additionally, the Auxiliary Data Collection Shockwave Intravascular Lithotripsy (IVL) Dataset will need to be completed to participate in this 'real-world' study. Please ensure the Shockwave data set is completed for all applicable 2021Q3 patients (discharged after June 30, 2021), it is at your discretion to complete the Shockwave data set for patients discharged prior to this date.

Please be aware the weekly real-time aggregation of the COVID-19 detail lines is suspended as the Shockwave module implementation is finalized. This announcement will be updated with our progress, thank you for your patience.
